My Dear Vice Chancellor/Rector,

1. In continuation of the previous letter no. DG/QA/HEC/2008/112 dated: 07.07.2008 on the subject cited above (copy attached), I would like to draw your attention to the grievance conveyed by some faculty members to the HEC. The faculty feels that the decision of the HEC conveyed to the universities regarding approval of journals by respective BASRs of universities has not been implemented in letter and spirit.

2. According to the decision, the journals which were not declared as HEC recognized journals with regard to the publications before May 31st, 2005 are to be presented to BASR for consideration, approved journals. The HEC has agreed to recognize such journals if the respective BASRs and Syndicate give approval of such journals and provide the list to HEC.

3. It is requested that the issue of recognition of articles published prior to May 31st, 2005 be addressed as noted above.
